

WAIVER AND RELEASE OF LIABILITY FORM
(ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT)
By signing this document, you will waive certain legal rights, including the right to sue

Adrenaline Adventure Park/Adrenaline Paintball, its Officers, Servants, and Employees (hereinafter called the "Sponsors")

ASSUMPTION OF RISK

- 1) I, the undersigned, wish to play **Paintball a/o Low Impact a/o Airsoft**. I recognize and understand that playing **Paintball a/o Low Impact a/o Airsoft** (hereinafter called the 'Game') involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the Game and injuries resulting from tripping or falling over obstacles in the Game playing field. In addition, I recognize that the exertion of playing the Game could result in injury or death.
- 2) Despite these and other risks, and fully understanding such risks, I wish to play the Game and hereby assume the risks of playing the Game. I also hereby hold harmless the 'Sponsors' and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including legal fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the Game, including, without limitation, those resulting from the manufacture, selection, delivery, possession, use or operation of any and all equipment used in the Game. I hereby release the Sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors that I am in good health and do not suffer from a heart condition or any other ailment which could be exacerbated by the exertion involved in playing the Game. I agree to comply with usual customary rules, conditions and expectations of the Game. Furthermore, I agree to cease participation if I observe any deviation therefrom and to promptly report same to the Sponsors. **I further certify that I am 18 years of age or older.**
- 3) **The Assumption of Risk provisions apply to those under age 18 years. Furthermore, I assume all the said risks on behalf of my child, or the child under my care, who is under the age of 18 years.**

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of participating in the Game, I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I have, or may have in the future against **Adrenaline Adventure Park/Adrenaline Paintball**, their directors, officers, employees, agents and representatives, Donald Muscutt and Margaret Tuffin the property owners (all of whom are hereinafter collectively referred to as 'the Releasees')
2. **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, injury or expense that I may suffer or that my child under the age of 18 may suffer, or that my next of kin may suffer as a result of my participation in the Game due to any cause whatsoever, **INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES.**
3. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for any damage to property of, or personal injury to my child under the age of 18, any third party, resulting from my participation in the Game.
4. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns.
5. **Model Release Form** I hereby give Adrenaline Adventure Park/Adrenaline Paintball permission to use my photographs or video images, (if any are taken). I waive any rights to the photographs and the use and reproduction of them, for any purpose, whatsoever, without any compensation. All images shall be considered the sole property of Adrenaline Adventure Park/Adrenaline Paintball. I understand that if I wish to opt out of this, I must notify Adrenaline Adventure Park/Adrenaline Paintball in writing.
6. I agree to give Adrenaline Adventure Park/Adrenaline Paintball Express permission to email me with promotions and special offers related to Adrenaline Adventure Park/Adrenaline Paintball. The email information provided is strictly confidential and will not be sold, loaned, rented, or given to any other individual or organization for any purpose, whatsoever
